CloudForte includes a Cloud Management Platform (CMP), providing a single-pane console for multi-cloud and hybrid-cloud deployments and management and operations. It uses accelerators to utilize the CMP into the cloud, with the CMP becoming the lynchpin for any management and operations going forward through fully managed services capabilities. It enables hybrid cloud automation with rapid provisioning and self-healing.
