WNS Global Services, headquartered in Mumbai, was a former British Airways captive company that was listed on NYSE in 2006. In 2008, it acquired Aviva Global Services, the Singapore based holding company of insurance group Aviva's offshore BOT (Build-Operate-Transfer) facilities in Bangalore, Pune, Chennai and Colombo. This acquisition, valued at \$228m, marked a change in focus for WNS; the company acquired the whole of Aviva's back-office, covering both general and life insurance operations, and this formed the basis of the vertically specialized services that WNS now provides.
