In March 2010, NorthgateArinso acquired Convergys' HR management business, which brought several large MPHRO clients, and ~2,300 employees. Convergys' prime service was MPHRO followed by learning and benefits administration. The combined company has ~8,500 employees providing HR strategic business consulting, outsourcing services, systems integration and software solutions.

NorthgateArinso offers three different levels of payroll outsourcing services; payroll processing, managed services and comprehensive HRO.

This NelsonHall vendor assessment analyzes NorthgateArinso's offerings and capabilities in Payroll Services Outsourcing. NorthgateArinso is one of a number of Payroll Services Outsourcing companies analyzed in NelsonHall's comprehensive industry analysis programs.

NorthgateArinso offers three different levels of payroll outsourcing services. These services are payroll processing, managed services and comprehensive HRO

Payroll services are delivered from NorthgateArinso's shared service centers that support EMEA, North America, Latin America and APAC regions. NorthgateArinso provides personnel in-country as well, including tier 2 support.

In the U.K. NorthgateArinso targets organizations of different sizes, from under 500 employees to multi-national large clients. Outside of the U.K. NorthgateArinso focuses on the enterprise market segment, with employee sizes of 5,000 and above.
