Headquartered in Montreal, Quebec Canada CGI was formed in 1976. In May 2012 CGI announced its intent to acquire U.K. headquartered Logica and completed the acquisition in August 2012.

The combined company has ~71,000 employees in ~40 countries and has global delivery centers in the Americas, Europe and Asia Pacific. CGI is a global provider of:

- Business process outsourcing services
- Information technology management
- Systems integration, development and consulting.

This profile focuses on CGI's global payroll services outsourcing business which in Canada is named CGI payroll services center (PSC). CGI offers and provides both:

- Bureau payroll services, including:
 - Payroll administration
 - Mobile payroll services
 - Web-based reporting and online expense management
 - Software hosting and ERP integration
- Fully managed services for payroll and/or HR.

This NelsonHall vendor assessment analyzes CGI's offerings and capabilities in Payroll Services Outsourcing. CGI is one of a number of Payroll Services Outsourcing companies analyzed in NelsonHall's comprehensive industry analysis programs.

CGI offers and provides both:

In Canada, all payroll personnel are based in Montreal, Quebec. No offshoring services are provided in support of Canada. In Europe CGI utilizes a combination of onshore and off/near shore service delivery.

In Canada CGI targets the small market and most clients have fewer than 250 employees. In Europe, CGI targets small and mid-sized organizations of 100 - 5,000 employees in size.
