## **Key Findings & Highlights**

This NelsonHall vendor assessment analyzes TCS's offerings and capabilities in Multi-Process HRO. TCS is one of a number of Multi-Process HRO companies analyzed in NelsonHall's comprehensive industry analysis programs.

TCS is an Indian headquartered human resources business process outsourcing (HR BPO) provider, offering MPHRO, payroll, and learning BPO services. Its MPHRO offering includes workforce administration, payroll, benefits administration, compensation administration, resourcing services, and talent management (i.e., learning and development).

Its core MPHRO bundle that is purchased by majority of its clients includes workforce administration and payroll services. Approximately 55% of clients include other HRO services with compensation and benefits administration added-on the most frequently.

TCS primarily targets its existing BPO clients for its MPHRO services. As a result, it has several multi-tower BPO contracts including contracts with The Nielsen Company and Dow Chemical.
