Who Is This Vendor Assessment For?

NelsonHall's Managed Service Program vendor assessment for Allegis Global Solutions is a comprehensive assessment of Allegis Global Solutions' managed service program (MSP) offering and capabilities, designed for:

- Sourcing managers investigating sourcing developments within MSP
- HR decision makers exploring the benefits and inhibitors of MSP as evidenced from the clients and vendor capability
- Vendor marketing, sales and business managers developing strategies to identify developments and target opportunities within managed service programs
- Financial analysts and investors specializing in, or covering the HR outsourcing industry and suppliers.

Key Findings & Highlights

Allegis Global Solutions (previously known as Allegis Group Services) offers primarily vendor neutral MSP services across the Americas, Europe, and Asia Pacific. In 2014 it had ~100 MSP programs, and a spend under management of \$12bn, with a growth of ~10% y/y. Allegis Global Solutions is the MSP/RPO division of Allegis Group Inc., a private company and the largest staffing company in North America.

Talent2 began working with Allegis Global Solutions in 2010, and in 2011 formalized a strategic partnership to offer MSP and RPO services as a blended offering. Today the combined Allegis Global Solutions entity has ~800 personnel dedicated to its MSP business, and has three main hubs in Bracknell (U.K.), the Philippines and India.
