Over the past year, Firstsource has shifted from calling themselves "Digital First, Digital Now" to an "Al-First" strategy utilizing Al, generative Al, process mining, and automation to solve client challenges. Firstsource's healthcare practice is the second largest vertical within the company. In the U.S., it works with 1k hospital providers, 8 of the top 10 health plans, and 19 blue plans. It has processed 250m claims transactions and 15m customer interactions in the past year.
