Founded in 1992 as Top Echelon Contracting (TEC) and serving small and midsize staffing and recruiting agencies, TEC rebranded as FoxHire in 2019. The organization's EOR platform and global expansion launched in 2019, serving contingent and remote use cases in highly regulated industries, including the following:

- Staffing and recruiting FoxHire supports staffing and recruiting agencies as their back office, enabling them to scale their contract staffing businesses while remaining compliant and financially strong
- Enterprise FoxHire supports enterprise clients as their EOR partner, enabling them to hire anywhere in the world quickly and compliantly.

FoxHire primarily provides FTE, contingent worker, and independent contractor services in the United States but maintains capabilities in ~125 countries. It supports talent engagement models through intermediaries, e.g., staffing firms, gig platforms, and MSPs, and directly with enterprise clients through direct sourcing and other talent management programs. The company's expertise and IP are designed explicitly for small-market organizations within highly regulated industries, including education, healthcare, and technology, although FoxHire supports ~550 clients across ~14 sectors.

FoxHire's global EOR solution supports payrolling, onboarding, insurance, and compliance, helping companies seeking to expand their operations internationally without establishing in-country entities in new countries.
