LTIMindtree then provided these services to real estate and construction clients. It has focused on data collection to build these ESG capabilities.

LTIMindtree started delivering ESG services in 2018 for the banking industry. The BFSI industry is the largest industry sector for LTIMindtree. The first project was for an asset management firm in the U.K. They wanted support in defining a portfolio strategy for customer pursuits where the investment decision was based on an ESG investment strategy. The project was initially conceived as a data sourcing and management project. The project ultimately supported the client in the following ways:

- Creating a better understanding of its data lifecycle
- Generating and reporting on green alpha (investment returns based on green criteria).
