Key Findings & Highlights

Neeeyamo is a global payroll and EOR solutions provider. Since its inception, Neeeyamo has developed proprietary tools to enable its Global Payroll and Global Work solutions, dedicating ~25% of its annual revenues toward R&D efforts. Neeeyamo provides payroll services for ~270 clients and ~1.2m active employees.

Neeeyamo actively provides payroll support in ~145 countries, through its single global payroll platform, Neeeyamo Payroll. In these countries, currently, ~115 country payroll is processed by Neeeyamo's native gross to net calculation engines. The additional countries are supported via payroll service partners, which provide a unified global user experience through the same platform. In May 2023, it launched Neeeyamo Payroll 3.0, offering an upgrade of its product aimed at processing global payroll in less than five clicks.

Neeeyamo's delivery team spans ~80 countries, with its offices in 37 countries and ~1.4k employees dedicated to payroll.
