Paychex (NASDAQ: PAYX) provides integrated human capital management solutions built on a payroll foundation, offering HR, benefits, and insurance services for small and mid-sized businesses. It primarily supports the U.S. market and select countries of Northern Europe. Paychex brings ~50 years of experience in delivering payroll and benefits for the SME market, and its offerings are enabled through its proprietary HCM technology, including:

- HR outsourcing services (HR, payroll, benefits for the U.S. and some European markets)
- PEO services (U.S. co-employment)
- Retirement planning services (U.S. only)
- Insurance services (U.S. only).

The company employs ~16k employees and supports ~740k clients, mainly SMEs (organizations with up to 1k employees). It pays ~11m employees, handling payments to every 12th private sector employee in the U.S. Its U.S. proprietary technology is Paychex Flex. It supports ~3m monthly users on a hybrid cloud infrastructure offering HR and payroll functionality.
