The company's growth strategy comprises organic and inorganic growth to broaden its global footprint and client and service portfolios. PeopleScout's acquisition of TMP Holdings LTD in 2018, with its Yocto RPO brand, gave PeopleScout a presence in the U.K. and Continental Europe.

TrueBlue has announced several leadership appointments in the past two years, notably the assignment of its President and Chief Operations Officer, Taryn Owen, in September 2022.
