### Who is This Vendor Assessment For?

NelsonHall's quality engineering services profile on TestingXperts (Tx) is a comprehensive assessment of TestingXperts' offerings and capabilities, designed for:

- Sourcing managers monitoring the capabilities of existing suppliers of software testing/quality assurance/quality engineering, and application services/ADM
- Vendor marketing, sales, and business managers looking to benchmark themselves against their peers
- Financial analysts and investors specializing in the IT services sector and examining growth areas within IT services.

## **Key Findings & Highlights**

TestingXperts was founded in 2013 in both London, U.K., and Harrisburg, PA, to provide testing services. The company has based its model on an India-centric global delivery network: approximately 700 of its 850 headcount is in India, primarily in Hyderabad and Chandigarh. The remaining personnel is spread mainly across the U.S., U.K and, increasingly, in the Netherlands.

Automation is a significant element of the strategy of Tx, with the firm focusing on test automation across functional testing, non-functional, and specialized testing services. Within automation, continuous testing is the priority. In parallel, the company is increasingly taking a consultative approach with its clients, organizing workshops, mostly around continuous testing and automation. The company continues to create accelerators.

In the past 18 months, Tx focused on UiPath, creating an UiPath test framework, integrating UiPath's Orchestrator software product, targeting E2E/business process testing. The company has a partnership with UiPath to accompany the ISV in expansion from RPA to software testing, focusing on functional testing execution. This UiPath partnership is a significant effort for TestingXperts, which has trained 40 consultants on this initiative.

Another key partner is Tricentis, mainly around the Tosca product. Tx continues to find much client appetite for Tricentis products and is investing in this partnership. An example of its investment is its script migration automation from Micro Focus UFT and Selenium to UiPath Test Suite and Tricentis Tosca. A recent partner is Sofy.ai for mobile app testing.
